### **Course Description:**

Construction Law is the body of the law associated with the building and design of individual homes, shopping centers, residential communities, public roadways, skyscrapers, and other "improvements". This course provides a general overview of the construction process and "construction contract documents", exploring typical legal disputes which arise among developers, contractors, subcontractors, architects and engineers. The course will examine the statutory and common law liabilities which attach once the construction process has been completed, with an emphasis on the rights and remedies of those who purchase defectively constructed or designed homes and buildings.

**Course Objectives and Outcomes**: To provide students with a broad understanding of the parties, documents, disputes, rights, and remedies involved in all types of construction projects. All perspectives will be explored through the analysis of common construction law issues.

**Grades:** Grading will be based primarily upon one final examination with class participation factored in. Further details will be provided toward the end of the semester. With a small, seminar style class, all students are expected to participate regularly. Small group and drafting assignments may also be given.

**Assignments/Participation:** Students will be expected to have read the assigned materials and be prepared to discuss the relevant topic(s) during each class.

Attendance: Class attendance is a primary obligation of each student whose right to continued enrollment in the course and to take the examination is conditioned upon a record of satisfactory attendance. A student who exceeds the maximum allowable absences (5) may be compelled to withdraw from the course, or may be barred from sitting for the final exam. A student who is compelled to withdraw or is barred from sitting for the final exam may receive an "F" in the course. Attendance will be taken at the beginning of each class. A student who is present but unprepared for class, who is more than 5 minutes late, or who leaves early may be treated as absent. If you must be late to class, enter as quickly and quietly as possible to minimize disruption. If you are expecting to be late or

absent, please do not call, email, fax, or text me. Obtain notes from a classmate and catch up before the next class.

**Computers:** Students may use laptop computers for class-related purposes only. You are expected to pay attention and participate throughout the class and avoid distracting your classmates.

**Food and Beverage:** Snacks and drinks are permitted during class provided that you avoid loud and messy items. Please clean up after yourself.

Class Cancellation: If the instructor must cancel a class, notices will be sent to students via email and posted on the classroom door.
