## **COURSE DESCRIPTION, OBJECTIVES, AND STUDENT LEARNING OUTCOMES**

This course will integrate substantive criminal law with legal analysis, research, and writing, combining skills and doctrine, as lawyers must in everyday practice. You will be called upon to write and speak in every class, and you will work regularly with a partner or a team in solving problems. Through these methods and others, you will develop your ability to perform legal analysis based on the doctrine of criminal law, and you should be able to apply your new skills of legal analysis, especially rule synthesis and analogical reasoning, to other courses and assignments. You will practice and perform written legal analysis, fundamental research tasks, and spoken legal argument throughout the semester.

## **COURSE EXPECTATIONS – PROFESSIONALISM AND COLLABORATION**

My goal in this course is, primarily, to set you on your path to becoming a lawyer. In that effort, I will treat you like lawyers, and you should aim to act like lawyers, specifically, to treat your classmates and me with respect and professionalism. I expect you to: arrive early for class and be ready to begin on time; attend every class unless significant personal circumstances interfere; alert me by email when you plan to miss class; and be prepared for every class by reading the assigned texts and *thinking about* the material.

The American Bar Association Accreditation Standards establish guidelines for the amount of work students should expect to complete for each credit earned. Students should expect approximately one hour of classroom instruction and two hours of out-of-class work for each credit earned in this class, though some of that work will be more concentrated around the production of graded, written assignments. For perspective, that is 18 hours of in and out of class time devoted to this course each week.

Unless otherwise directed, you may not collaborate on any graded writing assignments. You may be required to work as a team on ungraded written legal analysis assignments, and you will be required to work with a partner on research and editing for your second memo assignment.

I strongly encourage you to form study groups for reviewing criminal law and to meet with your study group regularly.

## **ASSIGNMENTS AND GRADING**

You will receive two grades for this class. You will receive one grade worth three credits in Criminal Law. You will receive one grade worth three credits in Introduction to Layering Skills.

### ***Three Credits in Criminal Law***

There will be one three-hour, limited-materials Criminal Law exam at the end of the semester worth 90% of your final grade

There will be five asynchronous reading reflections/problem assignments. Each assignment is worth two points, and you will receive two points so long as your work demonstrates good faith effort. Late assignments will receive a grade of zero. These five assignments will make up 10% of your final grade.

Law Scholars will serve as tutors to supplement your primary instruction in Criminal Law. Your attendance in these sessions is not required, though I strongly encourage you to attend and participate. The law scholar will provide a global review of each problem assignment so that you may self-assess the substance of your work.

### ***Three Credits in Introduction to Lawyering Skills***

You must complete two graded, writing assignments, two individual consultations with the professor, several small group sessions with the professor, and an interactive, asynchronous research and citation curriculum. I will provide grading criteria in advance for each writing assignment.

You must submit all assignments electronically to Sakai, unless otherwise directed, and you must maintain a copy. Failure to submit an assignment on time, will result in a 20% deduction, provided that you submit the assignment within 24 hours of the due date/time. After 24 hours, you will receive a ZERO for the assignment; however, you must turn in all assignments to pass the course.

Teaching Assistants and Law Librarians will supplement the primary instruction for citation, research, and core grammar skills.

Closed-Research Office Memo (25%) [POSTED 8-27-2021 // DUE 09-19-2021]

This exercise focuses on the skills of legal writing, analysis, and reasoning. The memo shall not exceed five pages.

Open-Research Office Memo (50%) [POSTED 10-15-2021 // DUE 11-21-2021]

This exercise develops the skills of legal reasoning, research, and writing. You will build on the skills you developed in writing the closed-research memorandum and use your newly developed legal research skills to perform the research. For this assignment, you must work with a partner on research, planning, and editing. However, your final written product must be your own work. The paper shall not exceed eight pages.

Memo Consultations, Small Group Meetings, Research/Citation Modules, and Core Grammar (25%)

You will be graded on the following criteria:

- Presenting a complete draft of each memo assignment at consultations;
- Demonstrating preparation and participating fully in your consultation;
- Completion of Research and Bluebook exercises; and
- Completion of Core Grammar exercises.

You will complete a series of online instructional videos, CALI (Computer-Assisted Legal Instruction) Lessons, and Assignments relating to legal research and citation. You may work on these assignments AT ANY TIME during the semester, but you will be assessed for good faith completion by the listed due dates.
